## PM World Inc. Author Agreement

This Agreement is between PM World Inc. (hereinafter "PM World") and <u>(author name)</u> (hereinafter the "Author"). Author agrees to indemnify and hold harmless PM World, its assignees and employees in any action arising out of facts which constitute a breach of the above representations and hold them harmless for any and all third-party claims, damages, liabilities, costs, charges and expenses including reasonable attorney's fees arising out of any breach of above-mentioned representations, or relating to the content or publication of Submitted Works or their presentation.
