

# PM World Author Agreement

This agreement is between PM World Inc. and **Author Names Here** (hereinafter the "Authors") and covers the publication of the following article, case study, paper, report or other original document (hereinafter "Submitted Work") in the PM World Journal, in the PM World library, on PM World websites, and/or as otherwise agreed between PM World Inc. and Authors. 5. The Submitted Work was original and does not infringe on the copyright or other literary rights of others and does not violate the rights of privacy or libel other persons. If the work contains copyrighted material owned by a third party, Authors agree to obtain any necessary written permission to use the copyrighted material in the Submitted Work, and shall so inform PM World Inc. in writing prior to republication by PM World Inc.
